Events of force majeure will entitle UV-Technik Speziallampen GmbH to postpone the delivery of the product or the rendering of the service for the duration of the obstruction. Events of force majeure are events which completely prevent or unreasonably impeed the provision of a product or service and which are not attributable to UV-Technik Speziallampen GmbH c.g. legal strikes or legal lockouts, war, import and export bans, energy and raw material shortages, official measures/facts, delayed supply of merchandises to UV-rechnik Speziallampen GmbH step for events of the contract strike the stipulation of a grace period if he can prove that a complete or part performance of the contract is no longer or felevance to him because of the delay.

## Customer's Responsibilities, acceptance

- The customer must make available to UV-Technik Speziallampen GmbH all documents required for the performance of the subject of the contract free of cost and in a timely manner. UV-Technik Speziallampen GmbH is not obliged to check the content of the documents made available by the customer as well as such designated requirements (specifications, functions, and technical details) for potential flaws or infringements of third party rights following the implementation of the specified requirements, unless otherwise agreed ex-
- Insofar as the customer renders own services or services are rendered by third parties (including the delivery of goods) the contract party is responsible for the co-ordination of the individual work processes as well as the compliance with applicable and provisions for prevention of accidents
- and provisions for prevention of accidents. In case the contract party does not render his co-operation duties to the required extent or UV-Technik Speziallampen GmbH is inhibited in rendering the agreed due to circumstances within the contacting partner's risk, UV-Technik Speziallampen GmbH is exempt from the performance obligations for the duration of the impediment and to the extent of its impact and may ask for reasonable compensation for any additional costs incurred hereby. UV-Technik Speziallampen GmbH in that case will set off any expenses saved or amounts received from other orders. The risk of accidental loss or accidental deterioration of the contractual services is transferred to the contract party at the time he is in default with accepting delivery.

  If UV-Technik Speziallampen GmbH is obliged to perform work (Werkleistung) or to supply labour and materials (Werkleiferung), the customer is obliged to conduct a formal acceptance, within two weeks from the transfer of risk (see. § 6). If this does not happen, the acceptance shall be deemed to have occurred (acceptance fiction). Acceptance fiction is also deemed if the subject of contract possibly after completion of an agreed test phase- has been put to use.

## Passing of risk. Transport insurance

## Guarantee of Retention of Title

In the case of violation of the contractual obligations by the customer, in particular in case of delayed payment, UV-Technik Spezialiampen GmbH will nave the right to repossess the products. - The customer must handle the products with due care; in particular, he must adequately insure them at his own expense against damage by fire, water or theft at their replacement value. If maintenance and inspection work is necessary, it must be carried out at the customer's own expense.

In the case of pledgings or similar acts by third parties, the customer must inform UV-Technik Speziallampen GmbH immediately in writings on that UV-Technik Speziallampen GmbH can bring a legal action as provided for in § 771 ZPO. If the third party is not able to reimburse UV-Technik Speziallampen GmbH for court and extrajudicial costs of the legal action as provided for in § 771 ZPO, the customer will be liable for the loss incurred by UV-Technik Speziallampen GmbH. The customer is entitled to re-sell the products in an orderly business transaction; however, the customer already assigns at this point all receivables amounting to the final sum of the invoice (including VAT) of the receivable of UV-Technik Speziallampen GmbH that

he gains from the re-sale to his customer or third parties. This is the case irrespective of whether the contractual object was resold without or after processing. The customer remains authorised to collect this receivable even after assignment of the receivable. The authorisation of UV-Technik Speziallampen GmbH to collect this receivable litself, remains unaffected by his. However, UV-Technik Speziallampen GmbH undertakes not to collect this receivable as long as the customer meets payment obligations from the revenues collected, does not have any payment arrears and in particular has not applied for composition or bankruptcy proceedings or if payment has been stopped. However, if this is the case, UV-Technik Speziallampen GmbH can request that the customer of VI-Technik Speziallampen GmbH and informs the debtors (third parties) of the assignment.

The processing or alteration of the product by the customer will be done for UV-Technik Speziallampen GmbH at all times. If the product is processed with other objects that do not belong to UV-Technik Speziallampen GmbH, UV-Technik Speziallampen GmbH adquires the co-ownership of the new object in the ratio of the value of the contractual object (final invoice amount, indired) VAT) to the other processed objects at the time of processing. For the rest, the same applies to the object, created by processing, as for the product supplied under reservation.

If the post-fulfilment fails, the customer is entitled at its own discretion to demand a withdrawal or price reduction.   UV-Technik Speziallampen GmbH is liable in accordance with the legal regulations in so far as UV-Technik Speziallampen GmbH commits a culpidation or gross negligence of the representatives or vicarious agents of UV-Technik Speziallampen GmbH. In so far as UV-Technik Speziallampen GmbH is not provided to the contractule obligation, in this case, however, the liability for compensation is limited to the foreing in this case, however, the liabili
